**NARRATIVE**

On 5/28/2008 I, Deputy Sisco, spoke with victim, Drew Nelson, at the LEC in reference to a threatening phone call he received from his boss(suspect), Eric Bikas. Nelson advised that he works for the suspect at Aunt Sue's off Hwy 11 and that on todays date he called the suspect and told the suspect he would not be able to come into work due to being sick. The victim advised that he was asked by Bikas to bring the keys to open up the store. Nelson was dropped of by his father at the Pumpkintown Convenience Store(incident location) so that the suspect would not make the victim work. Nelson advised that he gave the keys to his father who went to the store and gave the keys to the suspect's mother. After the keys were dropped off the suspect called the victim and said, "I don't know who the hell Paul(victim's father)is talking to my mom like that." The suspect then told the victim that he was going to break Paul's
