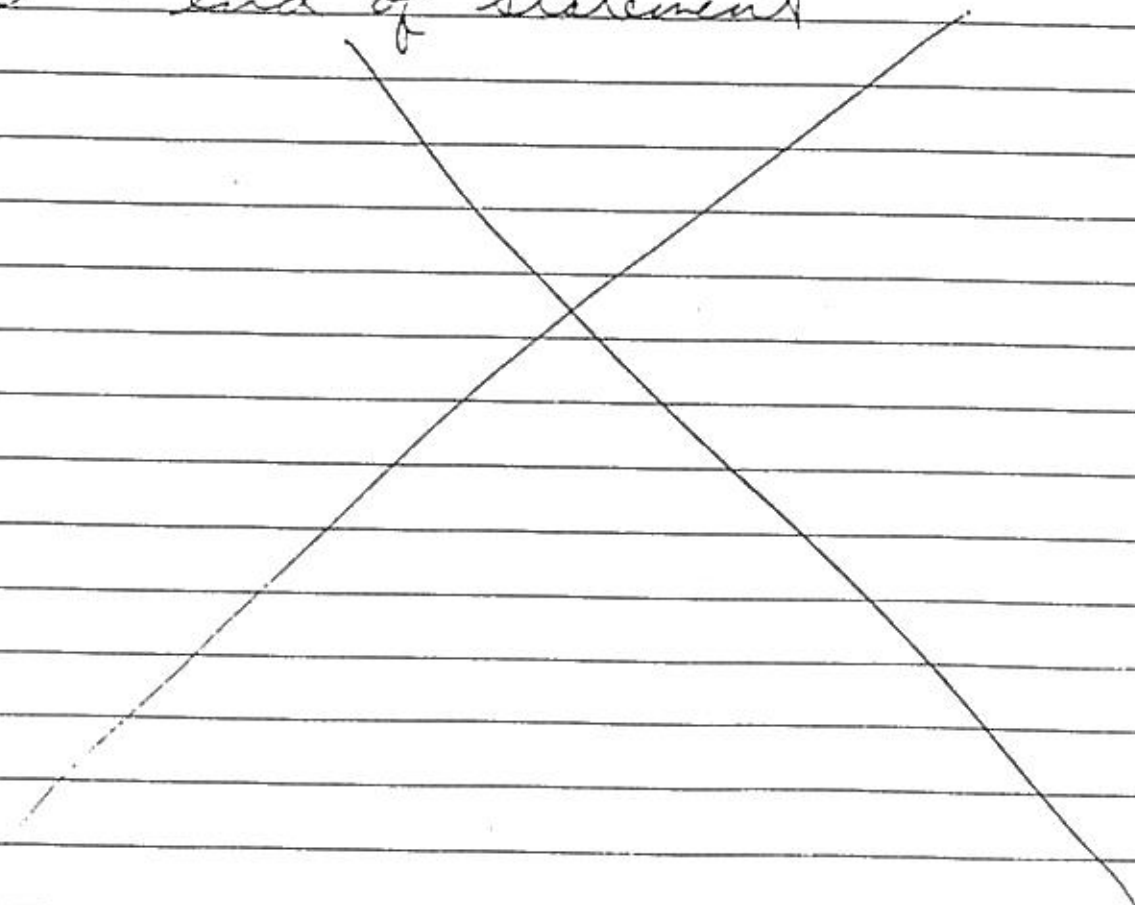

The window on the front of the bedroom showed no scratches or any marks. There is a Christmas candle between the window and the screen making it impossible to lock the window because of the electrical cord running inside.

To the right of the window, partially under the window is an exercise bike and thrown on the floor behind that to wall are throw pillows off the bed and stuffed animals. It appears to be impossible or at least tricky for someone to come through that window without hurting themselves on the exercise bike.

From the base board under the window to the bed is approximately 4 feet, from the door to front window is approximately 12 feet.

Outside running the length of the house is greenery, a type of holly neatly trimmed. The sections from the front porch to end of front of house victim's bedroom is in has three sections cut for access to wall of house under eaves. I observed no footprints in any of these sections, nor did I observe any broken twigs or limbs in front or behind the greenery. Even though the greenery is neatly cut there are twigs and limbs long enough to break particularly to get from open section to victim's bedroom window.

Under victim's front window I observed no footprints, disturbed earth, nor scrapes on the window sill though this was difficult because of the height of the window. The window is approximately 6'2" to 6'4" from the ground.

There is another window to victim's bedroom on the far side of the residence but it is higher off the ground than the front one. Again I observed no footprints, disturbed earth
