That on June 23, 2006 I/O along with Inv. Burn responded to 147 Tradd St. in reference to the victim advising that her estrange husband had just kicked in the front door and that he was still present. Upon our arrival I/O observed the front wooden door broken. The subject, Robert Turner was still present. According to Mr. Turner he had gone to his wife's residence to pick up 2 minor children to go to Africa for 2 weeks and he also needed some paperwork filled out by the victim. Mr. Turner left and he realized that his wife had not filled everything completely so he returned and attempted to call her on the phone with out success. When he did not get an answer at the door he broke the door to gain entry. Mrs. Turner was in the shower and did not answer the phone.

Mrs. Turner advised I/O at the time that she did not wish to pursue criminal charges due to the fact that he and their children were going to Africa for two weeks and they had planned this for some time.

Mrs. Turner advised later that she did wish to pursue criminal charges and a warrant was prepared for Damage to Personal Property \$1000. Mrs. Turner was advised to sign the warrant on Friday, June 30, 2006 at 0815 hours.

This case is pending upon service of the warrant.
